


# Covers of JIOS over the years









- Between 2-7 countries contributed to JOS in any one year

  - 1 year each from authors from Taiwan, Finland & Israel






### *In the first 11 years (1993-2003) of the JOS*

- authors from Australia, US, Canada, NZ and UK
  - Published a total of 152 articles **(96.8%)**
  - Australian authors published 54 of these articles
- 5 articles **(3.2%)** were from authors of the following countries:
  - 2 from Sweden & 1 each from Taiwan, Finland & Israel


### *In the last 10 years (2004-2013) of the JOS*

- Authors from Australia, US, Canada, NZ and UK
  - Publishing a total of 231 articles **(82.2%)**
  - 93 from American authors & 69 from Canadian authors
- 50 articles **(17.8%)** were published:
  - 22 from Sweden, 8 from Japan
  - Norway, Ireland, Netherlands, South Africa, Denmark, Austria, Israel, Taiwan, Finland, Slovenia and Brazil contributed 1-4 articles


## Percentage of Single & Multiple authorship articles in JOS per year

## KEY MESSAGES...

### ***In the first 11 years (1993-2003)***

- 5 (3.2%) articles by international author group
  - 4 articles were by authors of 2 countries
  - 1 article by authors of 3 countries

### ***In the last 10 years (2004-2013)***

- 30 (10.7%) articles by international author group
  - 25 articles were by authors of 2 countries
  - 5 articles by authors of 3 countries

## Limitations of this analysis...

1. This is a history of JOS only; discoveries & new understandings in OS are:
  - a. Published in other journals & books on occupation
  - b. Disseminated in cross-discipline literature
  - c. Disseminated on various electronic platforms – online sites and specifically discussion forums,
  - d. Shared on professional at meetings & conferences
2. Authors move influencing the country designated at the time of publication; some authors have multiple affiliations that cross borders
3. The use of keywords, the phrasing and appropriateness has changed over the 2 decades– relative comparison must be considered broadly
4. others...


## 2. Editorial decisions related to content that fostered international development & dissemination of OS

- ✓ Pages increased from 28 [Vol 1(2)] to 114 [Vol 20(4)] allowed for expansion of the number & types of manuscripts published globally
  - ✓ issues per year –
    - 2 from 1993-1994
    - 3 from 1994-2009
    - 4 from 2010-2013
  - ✓ instituting constructive critiques & editorial support for author teams
- 
- ✓ emergence of guest editors & special themed issues, for example:
    - 2009: *Placing Occupation*  
*Co-occupation across the life span*
    - 2011: *Occupations in Time & Space*  
*Canadian Contributions to the Field of Occupational Science*
    - 2012: *Occupational Science in Europe*  
*Redefining Boundaries & Bridges in Occupation*
    - 2013: *Social Policy & Occupational Science*  
*Occupation, Well-being and Immigration (x2)*



## **Future considerations to facilitate international collaborations in occupational science**

1. Special issue about international collaborations
2. Increase the international representation on the editorial board
3. Fast track papers with international authorship
4. Support societies dedicated to OS (attending conference, marketing conferences, support to publish work etc.) particularly emerging groups
5. To increase distribution, search-ability, and citation rate -- assess publisher bundling & apply for impact factor
6. Encourage & support the emergence of another journal for dissemination of occupational science
7. Other...
